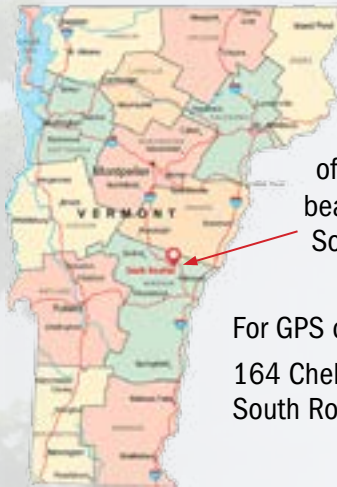


CLIC...

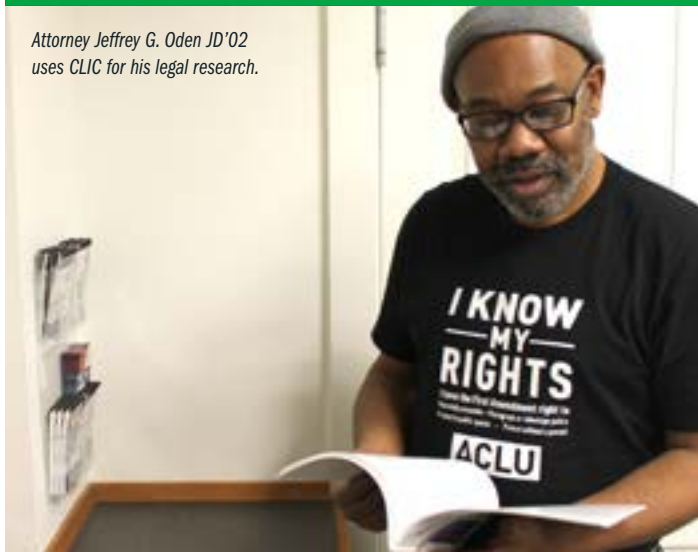
A reference librarian will be happy to assist you with your legal research questions. You are welcome to:

ABOUT CLIC

The Community Legal Information Center (CLIC) opened in July 2015 after the Vermont State Library's law program closed in Montpelier. Financed by an annual grant from the Vermont Department of Libraries and operated by VLS librarians and staff, CLIC offers free legal reference services for the general public:

WALK-IN ACCESS to Westlaw and LexisAdvance, legal databases containing primary (court decisions, statutes, and regulations) and secondary (encyclopedias, treatises, and dictionaries) sources.
